Junior Membership: Membership of the Colts Section is available only to young persons who, at the start of the school year, are aged between nine years and under seventeen years. Application for membership to the colts section must be made, on behalf of the applicant, by the applicant's parent or legal guardian. Subject to an interval of at least two clear days between nomination and admission and payment in full of the colts annual subscription, the applicant's parent or legal guardian shall be afforded the benefits of club membership with the exception of: Voting Rights, eligibility to make nomination, holding office or, standing for election to the Executive Committee of the Club. Such privileges to which the parent or legal guardian is entitled shall apply only whilst their charge remains a member of the colts section of the club.

The Club Committee may refuse membership, or remove it, only for good cause as conduct or character likely to bring the club or sport into disrepute. The parent or legal guardian who has proposed this Junior Membership application, as above, shall be responsible for the behaviour and conduct of the Junior (Colt) Member at all times that the Junior Member is representing the Club or attending the Club premises and shall declare that they and the Junior Member shall abide by the Rules and Bye-Laws of Luton Town & Indians Cricket Club.
